PEOPLE'S CHOICE BACH OF THE YEAR AWARD (People's Choice Award)
TERMS & CONDITIONS

1. These terms and conditions relate to the Bookabach Bach of the Year Awards 2018. Award nominations shall be deemed acceptance of these Terms and Conditions.

THE PROMOTER:

2. The Promoter is Bookabach Limited, NZBN 9429032997149 of Level 10/11 Britomart Place Auckland, 1010, New Zealand

NOMINATION PERIOD:

3. Nominations for the People's Choice Award as part of the Bookabach Bach of the Year Awards will open on 18 October and close at midnight on 1 November 2018.

4. HOW TO ENTER:

5. Entry is open to everyone except property owners, managers and agents who cannot vote for their own property under this Award category.

6. To enter, participants vote for their favourite property on the Bookabach awards microsite - <https://bachoftheyear.co.nz/>

7. The voting form will require the participant to provide contact information including name, and email address and provide a reason as to why the property deserves to win the People's Choice Award.

8. The most original justification response will be awarded NZD\$10,000 of booking value to use on Bookabach.co.nz or HomeAway.co.nz (each, the Site), valid for one year.

9. Only valid entries will be included. Incomplete entries and those that don't agree to these Terms and Conditions will be invalid and will be excluded. Properties that do not have an active listing on the Site at the time of review will be deemed invalid.

10. Participants may vote only once.

11. The Promoter reserves the right to verify the validity of entries and to disqualify any entrant who tampers with the entry process, who participates in a manner not in accordance with these Conditions of Entry or who has, in the opinion of the Promoter, engaged in conduct which is or may be fraudulent, misleading, deceptive or damaging to the goodwill or reputation of the Promoter.

PEOPLE'S CHOICE AWARD JUDGING:

12. The winner of the People's Choice Award will be the property with the most votes. If

there is a tie in numbers then the Bookabach team will make a decision based on the below criteria:

- Conversion
- Professional looking photographs
- Quality of property description and accurate features
- Guest reviews

13. The decision is final and at the discretion of the promoter.

14. The Promoter reserves the right to request the winner to provide proof of identity and/or age and/or residency of the award recipient. Identification considered suitable for verification is at the discretion of the Promoter.

VOTER PRIZE:

15. The vote with the most original reason as to why the property deserves to win the People's Choice Award, as decided by the Promoter, will be awarded NZD\$10,000 of booking value to use on the Site and will be valid for a period of one year as noted on the issue date.

16. Only valid entries will be eligible – property owners, managers and agents and The Promoter are exempt from winning the stay.

17. The Promoter's decision is final.

18. The winner will be notified through the email provided on the nomination form. If the email is incorrect or no response is received within 10 working days the winner will be invalid and another winner will be chosen.

19. The terms and conditions for redemption of the stay will be outlined in the email. The value of the prize is NZD\$10,000 .
